## **FEES:**

All exhibitors will be charged fees as determined below. All booth fees are non-refundable.

### ARTISANS/CRAFTERS/RETAIL:

- ~ (1) 10' x 10' Booth Space (\$410.00) Total 24.5 selling hours electricity included **FOOD TRUCKS / VENDORS:**
- ~ (1) 10' x 20' Booth Space (\$825.00) Total 24.5 selling hours electricity included (50 AMP)
- ~ (1) 10' x 20' Booth Space (\$800.00) Total 24.5 selling hours electricity NOT included

## \*\*NEW\*\* WIFI WILL BE PROVIDED FOR YOUR POS SALES\*\*

- All sales, taxes, etc. are to be handled by the vendor.
- No commission on sales.
- The booth fee is due only after invitation is extended and accepted.
- Food vendors will also be juried.
- It is preferred for all food vendors to be completely self-contained. (\*EU Generators or generators running 60 decibels or under ONLY).
- Submit 5 quality images {include 1 booth shot} IMPORTANT: Jurors judge off of PHOTOS ONLY. Please be sure and submit your best. Links to website, Etsy pages, or social media that gives an accurate depiction of your items and booth setup are also acceptable.
- Only ONE application per vendor allowed.
- All booth spots include power (with the exception of food vendors & a few on N. Main St).
- There WILL be a waiting list.

It is the responsibility of vendors and their employees to be informed about and comply with federal, state, and local health regulations and licensing requirements related to their products, display, distribution, sampling, and sale BEFORE applying to the Christmas Stroll.
